Referring to the subject cited, it is brought to our notice by our member companies that were part of petition in the Supreme Court that Hon'ble Commission has sent show cause notices (vide Ref.1) to the Respondents seeking objections/ suggestions, if any, on the proposals of CSS to different categories on consumers availing Open Access in Transmission and Distribution system at different voltages for 2015-16 **by February 15, 2024**

In this regard, we like to submit, on behalf of our member companies, that the time provided (3 weeks) to file the objections / suggestions is not sufficient as the number of documents - Filings of DISCOMs, Orders of High Court, Supreme Court and APTEL Judgements and the fresh proposal of ERC are huge in numbers.

Therefore, on behalf of our members, FTCCI requests the Hon'ble Commission to provide sufficient time to analyse all the documents / numbers and come out with their objections and suggestions. Keeping in view the importance of the subject, we request the Hon'ble Commission to extend the last date to submit the objections in O.P Nos 76 and 77 of 2015 by 4 weeks, i.e. **till March 15, 2024.**
