1. In terms of section 13 of the Electricity Act, 2003, the Telangana State Electricity Regulatory Commission had continued the exemption to the Co-operative Electric Supply Society, Sircilla Limited with Regd. No. 748 / T.D. Sircilla, from the application of section 12 of the Electricity Act, 2003 for the period of one year from 01.04.2015 to 31.03.2016 granted to it vide order of the erstwhile APERC No. 46 dated 15.06.2004. The exemption was based on the recommendation of the State Government of Telangana vide their letter No.390 / Budget / 2015 dated 29.04.2015.

2. The above RESCO, Sircilla has filed application in the format seeking extension of exemption granted earlier from the application of section 12 of the Electricity Act, 2003 for further period beyond 31.03.2016. The applicant filed all the relevant documents and also paid application fee of Rs. 30,000/- as per Clause 4 of Regulation No. 11 of 2013.

3. Whereas, after due consideration, the Commission is of the view that it is in the public interest and as per the recommendation of the Government of Telangana

State wide letter cited in reference (5) to grant further extension of the exemption granted earlier.

4. Accordingly, in exercise of the powers under section 13 of the Electricity Act, 2003, the Commission is pleased to extend the exemption which was earlier granted by it under reference 1st cited to the Co-operative Electric Supply Society, Sircilla Limited from the application of provisions of Section 12 of the Electricity Act, 2003 for a further period of five years from **01.04.2016 to 31.03.2021** subject to and on the same terms, conditions and restrictions contained in the licence (except that the words licence fee, which should be read as 'exemption fee') earlier granted to them under the provisions of the Andhra Pradesh Electricity Reforms Act, 1998 vide order of the erstwhile APERC No. 46 dated 15.06.2004.
