Dear Sir,

With reference to your letter cited above, it is observed that submitted RPPO computation for Heavy Water Plant, Manuguru is not in order.

Heavy Water Plant (Manuguru) which is a unit of Department of Atomic Energy, Govt. of India, has generated solar power of 15,716 MWh and 15,110 MWh for the financial Years 2020-21 and 2021-22 respectively. This data has not been considered while calculating the solar power obligation for the financial years 2020-21 and 2021-22. The solar power generation data is being submitted to SLDC in the first week of every month. Annual gross energy generation and consumption details of Heavy Water Plant, Manuguru for FYs 2020-21 & 2021-22 were already submitted vide reference letter Nos:2 & 3.

The details are attached once again for your kind reference. Hence you are here by requested to look in to the matter and do the needful, considering our solar generation, in calculating in house consumption and solar power obligation of HWPM. The revised computation data of RPPO of HWP(M) for the financial Year 2020-21 and 2021-22 may please be submitted to HWPM for further necessary action.

In reference to the obligation of purchase of non-solar power, detail procedures for purchase of non-solar power RECs may please be given.

With reference to the above, it is to inform that vide reference 2nd cited, the Hon'ble Telangana State Electricity Regulatory Commission has directed TSSLDC to obtain **comments** of the Obligated entities on the RPPO compliance computed by TSSLDC for the FY 2021-22 duly including the shortfalls of FY 2018-19, FY 2019-20 & FY 2020-21.

In accordance with the provisions of the Regulation No.2 of 2018 (TSERC Renewable Power Purchase Obligation (Compliance by purchase of Renewable Energy/ Renewable Energy Certificates) Regulations, 2018, the TSSLDC as State Agency, has computed the compliance to RPPO target for all the consumers for FY 2021-22 as enclosed.

In this regard, you are requested to furnish your comments for the RPPO computation, in case of any deviation, you are advised to submit necessary proof thereof.

Hence, it is requested to submit the above information to this office within 15 days from the receipt of this letter under copy to the Secretary (FAC), TSERC, Hyderabad failing which, it will be assumed that the RPPO compliance computed by TSSLDC is correct and it will be taken on record.
