Sub: - **TSSPDCL – IPC** – Seeking consent for the draft First Amendment (to the Power Purchase Agreement (PPA) dated 05.02.2002 between APTransco and M/s. Srinivasa Power Private Limited) dated 22.12.2021 extension entered with M/s. Srinivasa Power Private Ltd., 1 x 550 KW capacity Mini hydel power plant at off-take of Mudimanikyam Major from Nagarjuna Sagar Left Canal at KM 38 at Thummadam (V), Nidamanoor (M) of Nalgonda District -Reg.

This has reference to the information sought by the Commission in the matter of according consent to the draft amendment PPA entered with M/s Srinivasa Power Private Limited, a 0.55 MW Mini Hydel power project developer in Nalgonda (D) for extension of PPA for 3 years at a fixed levelized tariff of Rs.2.15/Kwh (inclusive of all taxes & duties).

In this connection, it is requested to place before the Commission the petition seeking consent for the draft amendment along with the following replies:

- (i) **Justification for procurement of power from above 550KW Mini Hydel plant at off-take of Mudimanikyam Major from Nagarjuna Sagar Left Canal at KM 38 at Thummadam, Nidamanoor (M), Nalgonda District**

Reply:

The 0.55 MW Mini Hydel power project of M/s Srinivasa Power Private Limited comes under Non-Solar RE category. It is submitted that the Non-Solar potential availability in the State of Telangana is limited and power from this Non-Solar RE source helps DISCOM in meeting the Non-Solar RPPO mandated by TSERC.

Further, many of the Non-Solar power purchase agreements under the jurisdiction of TSSPDCL are on the verge of completion of duration of their PPA period. The details are as submitted below:

When compared to other Non-Solar RE sources, tariff for the Mini Hydel power projects is low and the tariff now proposed @ Rs.2.15/Kwh (which is inclusive of all taxes, duties & levies) is economical.

As such, DISCOM has dual advantage of economical tariff as well as opportunity to avail Non-Solar power from this Mini Hydel project for meeting Non-Solar RPPO.

(ii) Draft Agreement commencement date and expiry dateReply:

Since the Developer furnished proposal for extension of their agreement after expiry of their PPA period, it is proposed for extension of PPA for three years from the date of execution of amendment PPA after consent of TSERC.

(iii) Details of original PPA dated 05.02.2002 transferred from APTRANSCO to TSSPDCLReply:

The original power purchase agreement was executed on 05.02.2002 (superseding the earlier Power Purchase & Wheeling Agreement dated 17.01.2000) between the then APTRANSCO and M/s Srinivasa Power Private Limited for sale of power from 0.55 MW Mini Hydel power project located on Mudimanikyam Major at KM 0-000 take-off from NSLC at KM 38-000, at Tummadam Village in Nidamanoor Mandal, Nalgonda District.

Under the third transfer scheme, the PPA was allotted to the then APCPDCL. After bifurcation of the state, the PPA is presently assigned to TSSPDCL. A copy of the PPA dated 05.02.2002 is enclosed herewith for ready reference.

The Applicant respectfully submits as under: -

1. The present Petition is being filed by the Southern Power Distribution Company of Telangana Limited seeking consent u/s 62 (1) (a) & 86(1)(b) of the Electricity Ac, 2003 and u/s 21 (4) of Telangana Electricity Reforms Act, 1998 for the draft First Amendment dated 22.12.2021 to the Power Purchase Agreement (PPA) dated 05.02.2002 executed between the then APTRANSCO and M/s. Srinivasa Power Private Limited for extension of PPA period for further 3 years at a fixed levellised tariff of Rs.2.15 per unit (inclusive of all taxes, duties, levies, if any) towards supply of power from 550 KW capacity Mini Hydel power plant at off-take of Mudimanikyam Major from Nagarjuna Sagar Left Canal at KM 38 at Thummadam (V), Nidamanoor (M) of Nalgonda District in Telangana.
2. That the Power Purchase Agreement dated 05.02.2002 was entered between the then Transmission Corporation of Andhra Pradesh Limited and M/s. Srinivasa Power

Private Limited for purchase of power from Mini hydel power project with 1 x 550 KW capacity on off-take of Mudimanikyam Major from Nagarjuna Sagar Left Canal at KM 38 at Thummamadam, Nidamanoor (M), Nalgonda District for a period of 20 years from the date of COD at Rs.2.25 paise per unit with escalation at 5% per annum with 1994-95 as base year and was to be revised on 1st April of every year up to the year 2003-2004. Beyond the year 2003-2004, the purchase price by APTRANSCO was decided by the then Andhra Pradesh Electricity Regulatory Commission. It is also provided that on completion of ten years from the date of commissioning of the project, the purchase price was to be reworked on the basis of Return on Equity, O&M expenses and the Variable Cost.

3. That the Government of Andhra Pradesh vide G.O.Ms No.58, dated 07.06.2005 had ordered transfer of bulk supply undertaking and PPAs from the then APTRANSCO to the four distribution companies (DISCOMs) in terms of Electricity Act, 2003. Accordingly, the PPAs held by the then APTRANSCO had been allocated to DISCOMs. The subject agreement stood transferred to Central Power Distribution Company of Andhra Pradesh Limited (APCPDCL) by virtue of the orders of the government in the above said memo.

4. That the Government of India had enacted the Andhra Pradesh Reorganisation Act 2014 (6 of 2014) CARVING OUT TWO NEW STATES OF TELANGANA AND ANDHRA PRADESH.

5. That the distribution companies as existing then stood allotted to the respective States in which their area of operation falls. Accordingly, the name of APCPDCL has been changed to Southern Power Distribution Company of Telangana Limited (TSSPDCL) due to formation of the State of TELANGANA, pursuant to the enactment of Act 6 of 2014.

6. That as per Article 7 of the PPA, the agreement may be renewed for such further period of time and on such terms and conditions as may be mutually agreed upon by the parties, 90 days prior to the expiry of the PPA and subject to the consent of the Commission.

7. That M/s. Srinivasa Power Private Limited has requested for extension of duration of PPA for a period of three (3) years and the TSSPDCL agreed for extension of duration of PPA for a period of three (3) years at a fixed levellised tariff of Rs.2.15 per unit (inclusive of all taxes, duties, levies, if any), and any other additional claims for payment

of MAT/IT/Water Royalty charges, etc., would not be paid to M/s. Srinivasa Power Private Limited, subject to the consent of TSERC and condition that M/s. Srinivasa Power Private Limited shall comply with the provisions of Regulations/Guidelines/ Orders/ Proceedings of Central Electricity Authority (CEA), Central Electricity Regulatory Commission (CERC) and Telangana State Electricity Regulatory Commission (TSERC), notified and as amended from time to time.

8. That the terms and conditions of the original agreement (PPA dated 05.02.2002) shall remain unchanged except clause 2.2 of the Article 2 (**PURCHASE OF DELIVERED ENERGY AND TARIFF**) & Article 7 (**DURATION OF AGREEMENT**).

9. That M/s. Srinivasa Power Private Limited shall not be eligible for obtaining Renewable Energy Certificates (RECs) as per prevailing regulations issued by CERC and TSERC for energy generated from their project and supplied to TSSPDCL under this agreement.

10. That the stated amendment agreement is enforceable from the date of execution subject to obtaining consent of TSERC as per section 21 of Telangana Electricity Reform Act 1998 (Act No.30 of 1998), u/s 62 (1) (a) & 86(1)(b) of the Electricity Ac, 2003.

11. That this amendment to the PPA dated 05.02.2002 is appended as **ANNEXURE** is agreed by both the parties and signed. The other clauses of Articles and Schedules of the Power Purchase Agreement dated 05.02.2002 shall remain unaltered. In view of this amendment, "APTRANSCO" shall be read as "TSSPDCL" in the original agreement.

12. Hence it is prayed that this Hon'ble Commission may be pleased to accord consent u/s 62 (1) (a) & 86(1)(b) of the Electricity Ac, 2003 and u/s 21 (4) of Telangana Electricity Reforms Act, 1998 for the draft First Amendment dated 22.12.2021 to the Power Purchase Agreement (PPA) dated 05.02.2002 executed between the then APTRANSCO and M/s. Srinivasa Power Private Limited for extension of PPA period for further 3 years towards supply of power from 550 KW capacity Mini Hydel power plant at off-take of Mudimanikyam Major from Nagarjuna Sagar Left Canal at KM 38 at Thummadam (V), Nidamanoor (M) of Nalgonda District in Telangana.
