TSERC – RECONSTITUTION OF STATE ADVISORY COMMITTEE (SAC).

Lr. No. TSERC/Secy/JD(IT)-SAC(2017)266,— In exercise of the powers conferred on it by Section 87 of the Electricity Act, 2003 (36 of 2003) read with TSERC (*Constitution of State Advisory Committee and its functioning*) Regulation No.4 of 2015 and in supersession of the State Advisory Committee notified on 30.01.2015, the Telangana State Electricity Regulatory Commission (hereinafter referred to as “*TSERC / Commission*”) hereby reconstitutes the “*State Advisory Committee*” (SAC) consisting of the following Members.

*The Secretary of the Commission shall be the *ex-officio* Secretary to the SAC.

- 2) In terms of the provisions of Section 87 (3) of the Electricity Act, 2003, the Chairperson, TSERC shall be the *ex officio* Chairperson of the SAC and the Members of the TSERC and Secretary to the Government of Telangana in charge of the Ministry or Department dealing with Consumer Affairs and Public Distribution System shall be the *ex officio* Members of the SAC.
- 3) In addition to the organizations included in the SAC, the Commission may co-opt any other organization/ expert/individual for any of the meetings of the SAC, as a special invitee.
- 4) The vacancy that would arise on account of any member leaving his organization would be filled up by a member, nominated by the Head of the respective organization.
- 5) The tenure of the Members of the SAC shall be for a period of three (3) years with effect from the date of this notification.
- 6) As per Section 88 of the Electricity Act, 2003 the objects and functions of the State Advisory Committee shall be to advise the Commission on the following issues.
 - a) major questions of policy;
 - b) matters relating to quality, continuity and extent of service provided by the licensees;
 - c) compliance by licensees with the conditions and requirement of their licence;
 - d) protection of consumer interest; and
 - e) electricity supply and overall standards of performance by utilities;
- 7) The meeting of the SAC shall be convened by the Commission. The issues for consideration of the SAC would be those either referred by the Commission for advice or issues raised by the Member(s) representing the electricity sector interests. The SAC could render advice either on a reference by the Commission or of its own motion on the above-mentioned issues.
