TSERC – Extension of exemption from the application of Section 12 of the Electricity Act, 2003 in respect of the Co-operative Electric Supply Society Limited, Sircilla (CESS) for a further period of five (5) years from 01.04.2021 to 31.03.2026 – Amendment of Orders – Communicated - Reg

In reference 10th cited above, the Commission in exercise of the powers under Section 13 of the Electricity Act, 2003 accorded extension of the exemption, which was earlier granted by it under reference 6th cited to the CESS, from the application of provisions of Section 12 of the Electricity Act, 2003, for a further period of five (5) years from 01.04.2021 to 31.03.2026 subject to and on the same terms, conditions and restrictions contained in the Licence (except that the words licence fee, which should be read as 'exemption fee' and the area of supply being eleven (11) Revenue mandals viz., Sircilla, Ellanthakunta, Musthabad, Gambhiraopet, Yellareddypet, Konaraopet, Vemulawada, Boinpally, Chendurthy, Rudrangi, Veernapally and Nallagonda & Thippaipalli villages of Kodimyal mandal) earlier granted to them under the provisions of the Reform Act vide order dated 16.06.2004.

The CESS in the letter reference 11th cited above, has stated that due to formation of new districts, municipalities/nagarapanchayats and revenue mandals in the State of Telangana, the nomenclature of revenue mandals in the licensed area of CESS got affected and as such area of supply mentioned in the exemption proceedings need amended as detailed below without affect of original license granted to CESS.

"Twelve (12) complete revenue mandals viz., Sircilla Urban, Vemulawada, Thangallapalli, Ellanthakunta, Mustabad, Gambhiraopet, Yellareddipet, Veernapalli, Konaraopet, Vemulawada Rural, Boinpally, Chandurthy and

Rudrangi village of Rudrangi mandal in Rajanna Sircilla district, Nallagonda, Thippaipalli villages of Kodimyal mandal in Jagitial district; and Gundaram village of Bejjanki mandal in Siddipet district;”

After careful consideration and in view of no change in original jurisdiction/licenced area/area of supply i.e., **no change in the area bounded by, specified in the licence No.5/2000 granted to CESS during the year 1999-2000 under the provisions of the Reforms Act, 1998 and the change being nomenclature of revenue mandals and newly formed districts**, the Commission hereby amends the order dated 31.03.2021 (Proceedings No.TSERC/Secy/22/2021 dated 31.03.2021) as follows:

AMENDMENT to Proceedings No.TSERC/Secy/22/2021 dated 31.03.2021

- 1. The words within brackets in para (5) of the Proceedings No.TSERC/Secy/22/2021 dated 31.03.2021 “and the area of supply being eleven (11) Revenue mandals viz., Sircilla, Ellanthakunta, Musthabad, Gambhiraopet, Yellareddypet, Konaraopet, Vemulawada, Boinpally, Chendurthy, Rudrangi, Veernapally and Nallagonda & Thippaipalli villages of Kodimyal manda” shall be read as “and the area of supply being twelve (12) complete revenue mandals viz., Sircilla Urban, Vemulawada, Thangallapalli, Ellanthakunta, Mustabad, Gambhiraopet, Yellareddipet, Veernapalli, Konaraopet, Vemulawada Rural, Boinpally, Chandurthy and Rudrangi village of Rudrangi mandal in Rajanna Sircilla district, Nallagonda, Thippaipalli villages of Kodimyal mandal in Jagitial district; and Gundaram village of Bejjanki mandal in Siddipet district”**
- 2. The words “vide order dated 16.06.2004” mentioned in last line of para (5) of the Proceedings No.TSERC/Secy/22/2021 dated 31.03.2021 stand deleted.**
- 3. Except for the above, all other terms contained in the Proceedings No.TSERC/Secy/22/2021 dated 31.03.2021 shall remain unaltered.**
